OUR EIGHTH ANNUAL LISTING OF GEORGIA'S TOP ATTORNEYS, selected by their peers, includes nine practice areas: business law; personal injury litigation; criminal law; labor and employment; taxes, estates and trusts; bankruptcy and creditors' rights; governmental affairs; family law; and general practice/trial law.

To compile the list we mailed ballots to last year's Legal Elite and to a sampling of lawyers who are members of the State Bar of Georgia and whose practice areas correspond to those we are featuring. We also included ballots on our website, www.georgiatrend.com, which could be downloaded and sent to us or submitted electronically.

Any attorney who is a member of the state bar and who lives and practices in Georgia was eligible to participate in the voting and to be voted onto Legal Elite lists. Respondents were not allowed to vote for themselves; but they could vote for other members of their firms, so long as they voted for an equal or greater number of attorneys outside their firms.

The names of the top vote recipients appear, in alphabetical order, in the following pages. Lawyers are listed in the categories into which their peers voted them, although some may practice in more than one area.

The listing is strictly an editorial project, determined by lawyers' votes; places on the list are not available for sale; nor are they tied in any fashion to paid advertising.

Ballots were tallied and names verified by Contributing Editor Christy Simo and the *Georgia Trend* editorial staff.
